DIRECTIONS FOR USE: Use only as directed.

CORN, CELERY: To control - Wireworms, apply 55-110 kg per ha on the soil before planting crops. Work into top 10-15 cm of soil. Use higher rate on heavier soils. Do not grow root crops in the treated soil for one year after application. For potatoes, wait for 2 years. To control - White Grubs, use 165-275 kg per ha, when breaking new ground. Apply before planting and before beetles emerge. Work into top 10-15 cm of soil. Use higher rates on heavier soils. Do not grow root crops for three years after application.

ORNAMENTALS and NURSERY CROPS: Grown outdoors - To control, Aphids, Thrips, Whiteflies, Leafrollers, Leaf miners, Plant bugs, Leaf beetles, Sawflies, Earwigs, Psyllids, Tent Caterpillars, dust lightly on all plant surfaces. Repeat in 7-10 days if necessary. Do not apply to food crops. To control Thrips on bulbs and corms, dust lightly before placing in storage.

GARDEN FLOWERS: To control - Aphids, Thrips, Flea Beetles,

Spittle bugs, Leaf miners, dust lightly on infested foliage. Repeat as necessary to control infestations.

LIVESTOCK: Apply to animal and rub into hair to skin. For lice, repeat in 14-18 days.

BEEF CATTLE: To control - Hornflies, Lice and Ticks*.

SHEEP, GOATS, HORSES: To control - Lice, Ticks*, and Fleas.

PIGS: To control - Lice, Fleas, and Mange Mites.

Limitations on Livestock:

1. Do not use on colts or calves under three months of age.
2. Do not use on sick or emaciated animals.
3. Do not use on dairy animals or in milk rooms.
4. Do not use on meat animals within 30 days of slaughter.

*Not applicable for control of tick paralysis in British Columbia.

DOMESTIC ANIMALS: DOGS - Use only on dogs and premises as indicated. To control Fleas, Ticks and Mites, dust on animals and rub into coat to skin. Repeat weekly if necessary. Do not dust on cats or nursing puppies. Consult veterinarian before using on pregnant animals.

DWELLINGS, INDUSTRIAL PLANTS, WAREHOUSES: To control - Houseflies, Stable flies, Mosquitoes, Gnats, Fruit flies, Earwigs, Crickets, Moths, Carpet beetles, Clothes moths, Larder beetles, Meal moths, Fleas, Bedbugs, apply as a spot treatment to areas of floor, walls and other infested areas. For clothes moths treat surface of closets and storage chests. Avoid use on surfaces that may contact food. Do not use in food cupboards. Remove or cover all food before application. For industrial plants, do not use while plant is in operation. Any treated surface that may contact food should be washed and rinsed thoroughly. Do not use in milk processing rooms, milking parlours or dairy barns.

DOG KENNELS: To control - Fleas and Ticks, dust on surface or bedding where insects may be hiding. Do not use on cats or nursing puppies.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid skin contact, inhaling or swallowing. Wash thoroughly after handling or using, and before eating or smoking. Wash contaminated clothing before re-use. Do not contaminate ponds, lakes or streams. Burn or bury empty containers. Lindane is toxic to fish, birds and other wildlife. Avoid treating areas inhabited by wildlife.

FIRST AID: If swallowed, cause vomiting. For eyes, flush with plenty of water. In case of skin contact, wash with soap and

water. Call a doctor in case of accident.

TOXICOLOGICAL INFORMATION: Poisonous if swallowed, inhaled or absorbed through the skin. Lindane is an organochlorine insecticide. Barbiturates may be given to control convulsions. Oxygen may be indicated. Keep patient quiet. Avoid use of morphine and adrenaline.

DISPOSAL:

1. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
2. Make the empty container unsuitable for further use.
3. Dispose of the container in accordance with provincial requirements.
4. For information on the disposal of unused, unwanted product and the clean-up of spills contact the regional office of Conservation and Protection, Environment Canada.
