DIRECTIONS FOR USE: For control of bacteria and fungi in drilling mud, VISCIDE 15B16 is used at the rate of 3.0 - 12.5 L per 10,000 L of drilling mud (0.024% - 1.2%). Add to pump suction or put in through the mud hooper.

For control of bacteria and fungi in secondary oil recovery waterflood systems VISCIDE 15B16 is used at the rate of 0.375-5.4 L per 10,000 L of water.

PRECAUTIONS: VISCIDE 15B16 is irritating to skin and eyes. Avoid contact with skin, eyes or clothing. Do not take internally. Wear goggles, rubber gloves and protective clothing (hat, long-sleeved shirt, long pants, boots) when handling.
