- Arsenic can be released during the use of this product. It is recommended that this product must not be used in circumstances that would result in arsenic air concentrations in the workplace exceeding levels established by occupational health and safety authorities in your jurisdiction. If values exceed this level, it is recommended that NIOSH approved respiratory protection be worn.
- Do not get in eyes, on skin or on clothing. Wash thoroughly after handling.
- Do not inhale vapors or spray mists. Use only in well-ventilated areas. Keep containers closed.
- When handling the concentrate, wear full-face protection with cartridge respirator, long sleeve shirt, long pants, apron, chemical-resistant gloves and boots. DIRECTIONS FOR USE: *Intercide ABF-2 DIDP is a formulation of 10,10'-oxybisphenoxarsine specifically designed for compatibility with flexible vinyl systems. It contains Diisodecyl Phthalate as its carrier.* The incorporation of approximately 1.5% by weight of Intercide ABF-2 DIDP based on the weight of the total vinyl system will usually provide protection against the surface growth of many mildew organisms. It is recommended that each formulation be tested in a qualified laboratory in order to determine the optimum level required for protection. ~~Akcros Chemicals America~~ can provide anti-fungal testing and/or assistance in formulation to meet individual requirements. It may be necessary to incorporate levels as high as 2.5% of this material in a vinyl system that is exposed to outside weathering. Intercide ABF-2 DIDP contains 10,10'-oxybisphenoxarsine in a formulation containing a primary plasticizer and can be substituted directly for the equivalent amount of plasticizer it is replacing.

DISPOSAL: 1) Triple- or pressure-rinse the empty container. Add the rinsings to the treatment site. 2) Follow provincial instructions for any required additional cleaning of the container prior to its disposal. 3) Make the empty container unsuitable for further use. 4) Dispose of the container in accordance with provincial requirements. 5) For information on the disposal of unused or unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.
