A prepared bait in convenient baitblocks, for the control of house mouse(musmusculus), roof rat (rattus rattus) and norway rat (rattus norvegicus) in dwellings, farm buildings, food service establishments (non food areas), storage areas (non food), feed and food processing plants (non food areas) and outdoor areas around buildings, where food, feed and food and feed packaging materials are never open or exposed. Will control the three species of rodents in as little as one feeding.

DIRECTIONS: Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.

RATS: Place 3 to 16 pieces of baitblox (usually at intervals of 4,5 to 9 metres) per placement. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

MICE: Place 1 piece of baitblox at intervals of 2.5 to 3.5 metres per placement. Two pieces may be needed at points of high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease. REPLACE CONTAMINATED OR SPOILED BAIT IMMEDIATELY. Collect and dispose of unconsumed bait and dead exposed animals according to local requirements. To prevent reinfestation, eliminate food, water, and harbourage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

IMPORTANT: Treated baits must be placed in locations which are not accessible to children, pets, domestic animals and wildlife or in tamper-resistant bait stations. Do not place bait in areas where there is a possibility of contaminated food or surfaces that come in direct contact with food.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife. Keep out of lakes, streams or ponds.

PRECAUTIONS: KEEP AWAY FROM HUMANS, DOMESTIC ANIMALS AND PETS.

IF SWALLOWED, this product may reduce the clotting ability of the blood and cause bleeding. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling. If swallowed, call a physician or poison control centre at once.

DISPOSAL AND DECONTAMINATION: Do not contaminate water, food or feed by storage or disposal. Store only in original container in a dry place inaccessible to children and pets. Dispose of stale bait and dead rodents in accordance with local requirements. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and clean up of spills, contact the Provincial Regulatory Agency or the Manufacturer.
