WOLMAN End Cut Preservative is a penetrating toxic wood preservative sealer and moisture repellent. It protects cut ends on WOLMANIZED PRESSURE TREATED LUMBER.

DIRECTIONS FOR USE: For exterior use only. Not for use in dwellings. Solution is not intended to replace pressure treatment. If field cutting or drilling of wood is unavoidable, apply two coats as supplied by brush only. Do not spray or dip. Do not dilute. Mix thoroughly and stir frequently during application. Wood to be treated should be clean and dry. Allow to dry before finishing or recoating. Use caution, as some paint finishes may cause bleeding. Do not use the preservative on treated wood where Zinc Napthenate may contaminate food, feed or drinking water. Do not apply to wood or fabric or any surface where prolonged skin contact may occur. May be used on greenhouse and garden timbers in contact with non-food producing plants only. Carrier solvent must be allowed to dry before introducing plants to prevent phytotoxicity. For untreated wood use WOLMAN WOOD PRESERVATIVE.

USE LIMITATIONS: Do not use this product as an antifoulant agent or as a preservative for marine or fresh water structures such as boats or wharfs.

PRECAUTIONS: Keep out of reach of children. Do not use for treating food contact surfaces. Do not use or store near open flame or spark. Avoid breathing vapours. Harmful if swallowed or inhaled. Wear appropriate covering and clothing when applying this product. Wear rubber or plastic gloves when handling product. Wash thoroughly after use with soap and water and before eating or smoking. Keep container closed when not in use. Avoid skin contact, may cause skin irritation. Do not contaminate bodies of water. This product is toxic to fish.

FIRST AID:
