Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, around door frames, windows and sills and along baseboards adjacent to them. Pay particular attention to cracks and crevices. Do not use as a space spray. Good sanitary practices should be maintained to prevent re-infestation. For carpet beetles, thoroughly apply as a spot treatment along baseboards and edges of carpeting, rugs and furniture.

PRECAUTIONS: Avoid contact with skin, eyes and clothing. Do not use as a space spray. Do not allow spray to contact food, feedstuffs and water supplies. In homes and dwellings, remove or cover all exposed foods and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before reuse. If accidentally swallowed, drink one or two glasses of water and induce vomiting by touching back of throat with finger and obtain medical attention at once.
