Directions for Use

Apply Tordon 10K Pellets brush killer in the spring or early summer before growth begins or during vigorous growth and when abundant rainfall can be expected. Distribute Tordon 10K Pellets uniformly as spot or broadcast treatment to the soil over the roots of woody plants. Use ground or aerial application equipment as directed below.

Spot Treatment - Spot application is generally the preferred method of treatment for scattered or sparse stands of brush. Spread Tordon 10K Pellets evenly on the soil over the entire root system (around the main stem) and outward to 30 cm beyond the branch tips (drip line) as shown in the illustration. Use at the rate of 100 to 200 g per 10 m² of soil surface. Use higher dosage also to control brush on very sandy, gravelling or rocky soils and in areas where heavy rainfall can be anticipated.

Broadcast Treatment - To control solid stands of very susceptible species such as maples, conifers, locust, aspen and wild rose use Tordon 10K Pellets brush killer at the rate of 67 kg/ha.

To control brush of mixed species use Tordon 10K Pellets brush killer at the rate of 85 kg/ha.

To control solid stands of hard to kill species such as blackgum, oak and ash use Tordon 10K Pellets at the rate of 95 kg/ha. Re-treatment of ash may be necessary the following year.

Ground Application - Use Tordon 10K Pellets at the rate of 67 to 95 kg/ha (approximately 670 to 950 g/100 m²) and distribute evenly over the entire area where brush is to be controlled.

Aerial Application - Apply Tordon 10K Pellets to electrical rights-of-way, military bases, pipelines and firebreaks at the rate of 67 to 95 kg/ha. Do not apply by air in other locations.

Apply only as recommended to avoid injury to desirable plants. Avoid applications during windy periods when the product may be blown away from area to be treated or onto any parts of desirable plants. Do not allow the material to contaminate any bodies of water. Where applicable, observe any local buffer zones or setback requirements. Do not store near food, feedstuff, seeds, insecticides, fungicides or other pesticides.
