2. Scoop out clumps and solids daily. Dispose of waste with regular garbage. The rest of the litter stays clean and fresh. Do not flush any cat litters.
3. Simply add more Ever Clean(R) when necessary to replace what you scoop out. Normally, you will not have to change the litter box again.

PRECAUTIONS: Pregnant or nursing women and people with a suppressed immune system should note that a parasite found in cat feces can cause toxoplasmosis. They should exercise caution and consult a physician before handling a litter box. Always wash hands thoroughly after preparing or cleaning the litter box.
