VET TEK B-R-S-Back Rubber Solution is a specially prepared formulation containing premium grade Malathion, in a ready-to-use form, for use in cattle treating equipment. VET TEK B-R-S combines quick knockdown and long lasting residual control of flies and lice, thereby providing the protection from these pests which is essential to alleviate animal discomfort and production losses.

With VET TEK B-R-S continuous control of troublesome pests can be

achieved. Cattle treat themselves when and where they require it. The residual action of VET TEK B-R-S provides control of lice as they hatch and controls flies long after treatment while the cattle are grazing on pasture. VET TEK B-R-S contains a light, non-irritating, low-odor oil.

This product can be used on lactating dairy cattle and on beef cattle right up to slaughter. Do not apply to animals under one month of age. Do not apply to livestock within 30 days of slaughter.

DIRECTIONS: VET TEK B-R-S is a ready-to-use insecticide formulation for use in cattle treating equipment. Simply add VET TEK B-R-S full strength to the back-rubber tank. No mixing is necessary. Refill the tank as required.

VET TEK B-R-S can be used in all cattle treating equipment except Sittner oilers. The back-rubber should be freely accessible and placed in the areas frequently used by the animals. One device should be continuously available for each 35-45 head of cattle.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. This product is harmful if swallowed, inhaled or contacted by skin. After filling cattle treating equipment, wash thoroughly with soap and water.

FIRST AID: In case of poisoning do not induce vomiting, this product contains petroleum distillate. Seek prompt medical attention. If in eyes, flush with water for 15 minutes and get medical attention. If on skin, wash with plenty of soap and water.

TOXICOLOGICAL INFORMATION: Malathion is a cholinesterase inhibitor. Atropine is antidotal.

DISPOSAL: Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make container unsuitable for further use. Dispose of empty containers in accordance with provincial requirements. Malathion breaks down rapidly in presence of water and alkaline materials such as lye, washing soap containing sodium hydroxide and bleach. Spills should be decontaminated with the use of one of these agents. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the Manufacturer.
