DIRECTIONS FOR USE:

The control of Brown Dog Ticks on dogs in kennels and other areas is becoming more and more difficult.

PARA (TM) POWDER for Fleas and Ticks has been developed to aid in the control of Brown Dog Ticks on dogs and premises. It is also very effective against fleas on dogs and cats.

For Control of Ticks and Fleas on Dogs and Cats: Dust powder liberally over the animal and rub thoroughly into the skin. Be sure to apply also to the feet, between toes and on the legs. Comb out dead ticks a few hours after treatment.

PARA (TM) POWDER may also be used to dust mother cats. Repeat at weekly intervals if needed.

For Kennels, Dog Houses and Sleeping Pads: Dust in and around sleeping quarters and other areas where ticks and fleas may hide.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. Harmful if swallowed or inhaled. Avoid breathing dust and contact with skin. Wash thoroughly after using.

Sensitive cats may exhibit temporary and non-harmful salivation. Minimize treatment of eyes or face. Do not use on nursing puppies or on kittens less than 8 weeks of age. Do not continue treatment if skin or nasal irritation develops. Do not treat eyes, face or scrotum. Do not use on sick animals. Do not use on animals under drug or pesticide treatment. For use on pregnant animals consult a veterinarian.

FIRST AID: In case of poisoning, call a physician immediately. If in eyes - flush with water for 5-10 minutes and obtain medical attention. If on skin - wash affected area thoroughly with soap and water.

TOXICOLOGICAL INFORMATION: Carbaryl is a cholinesterase inhibitor. NOTE TO PHYSICIAN: Atropine is antidotal.

STORAGE & DISPOSAL: Avoid storage near feed or food products. Dispose of empty containers with household garbage.
