DIRECTIONS FOR USE: Each briquette weighs approximately 450 g. For slime control in pulp, paper and paperboard mills, use 75 to 350 g per 1,000 kg of dry furnish. This product is not to be used in the production of paper or paperboard that comes into contact with food.

For bacterial and fungal slime control in industrial cooling water systems, add 10-25 mg/L once a week based on system's volume. If contamination is excessive, use 40-60 mg/L until the system cleans up. Feed directly from a wire drum or ball feeder to a point where it will be uniformly mixed. Do not apply to potable water supply.

PRECAUTIONS: This chemical is irritation to the skin and eyes. Avoid breathing dust. Use rubber gloves and goggles when handling.

FIRST AID: In case of contact with the skin, wash with plenty of soap and water. For eyes, immediately flush with plenty of water for a least 15 minutes and get medical attention. If swallowed, give patient repeated glasses of water and contact a physician immediately.

DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
3. Dispose of the container in accordance with provincial requirements.
