DIRECTIONS:

ULV APPLICATION: Treat terrain with 2.2 to 2.75 mg of d-trans allethrin and 11 to 15 grams of piperonyl butoxide per hectare. Best results are obtained by application when there is a slight breeze of 8 km per hour or less. Fog with the breeze so that the wind will carry the fog from the roads or paths into the areas to be treated. Repeat applications as needed to obtain desired reduction in adult mosquito population.

POWER BACK PACK FOGGERS:

PRO-5 ULV CONCENTRATE INSECTICIDE can also be used in back pack mist blowers such as the SOLS # 423. Treat terrain with 2.2 to 2.75 grams of d-trans allethrin and 11 to 15 grams of piperonyl butoxide per hectare.

Dilute 1 part of PRO-5 PLUS ULV CONCENTRATE INSECTICIDE with 6.5

parts of oil (by weight) to give a solution containing .67% d-trans allethrin plus 3.35% piperonyl butoxide. Fog this solution at the rate of 500 mL per hectare based on an 8 meter killing swath. Walk at a steady pace to give an accurate delivery.

PRECAUTIONS:

Keep out of reach of children and pets. Do not contaminate any body of water containing fish with spillages of this concentrate. Mix this concentrate will in drum before use. Keep container closed when not in use. Store in a cool, dry place. Product contains Petroleum Distillate. Do not store, pour or use near open flame. Wear a mask or respirator when applying the mist.

DISPOSAL AND DECONTAMINATION:

After use make the empty container unsuitable for further use by crushing/ Dispose of container in an approved land fill site in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environmental Protection, Environment Canada.
