DIRECTIONS FOR USE

GENERAL INFORMATION: Rates per 1000 litres are based on a dilute spray mixture. FIXED COPPER 50-W may be used in low volume or concentrate sprays by increasing the dosage to apply the same quantity of FIXED COPPER 50-W per hectare as would normally be applied when spraying dilute mixtures. Apply in sufficient water for thorough coverage of all plant parts; this volume depends on spray equipment and size of plants.

CROP	DISEASE	RATE AND METHOD
CUCUMBER, MELON, PUMPKIN, SQUASH	Angular Leaf Spot Anthracnose Bacterial Wilt Downy Mildew Fungus Leaf Spot	Use 4.5 kg in 1000 L of water per hectare. Spray at weekly intervals. For Bacterial Wilt Control it is necessary to control cucumber beetles. May be used up to each picking.

POTATO, TOMATO, CELERY	Early Blight Late Blight Septoria Leaf Spot Bacterial Canker (on greenhouse tomatoes)	Use 4.5 kg in 1000 L of water per hectare. Start early in the growing season with regular applications at 7-10 day intervals. May be used up to each day of harvest. For Bacterial Canker use at the rate of 3.25 kg in 1000 L/ha.
GRAPES	Downy Mildew Powdery Mildew	Mix 3 kg plus 6 kg of hydrated lime in 1000 L. Apply at Pre-bloom at 1500 L/ha and Post-bloom and in Cover sprays at 2000 L/ha until mid-August. Do not apply on Seibel varieties.
SOUR, CHERRY	Brown Rot Leaf Spot	Use 2 kg plus 4 kg hydrated lime per 1000 L of dilute spray. Consult local spray calendar for timing of application.
PEACH, APRICOT (British Columbia)	Coryneum Blight Peach Leaf Curl	Apply 9 kg/ha in September AFTER the harvest is completed.

COTON- EASTER, CRABAPPLE, HAWTHORN, MOUNTAIN ASH, QUINCE	Fireblight (see below)	Apply 1.25 kg/1000 L. Spray several times during blossoming; also repeat during summer when bacteria spread rapidly in warm, rainy weather.
ARBORATIVE, CEDAR, FIR, JUNIPER, PINE, SPRUCE	Leafblight Needlecast Tipblight Twigblight	Apply 4kg/1000 L of water when new growth starts in spring and repeat 3 to 4 times at 10 day intervals. Further sprays are advisable during prolonged rainy periods.

FIREBLIGHT: May be spread to healthy plants by insects such as aphids and leafhoppers. It is therefore, of utmost importance that regular applications with an effective insecticide such as Thioden, are made. Diseased twigs which appear to be "scorched" must be cut off 15 cm below the infected part and burned; disinfectant pruning shears after each cut in a solution of 1 part "Javex" to 4 parts water.

COMPATIBILITY: FIXED COPPER with lime can be mixed with most insecticides, Super-Spred Oil. FIXED COPPER with lime cannot be mixed with insecticide wettable powders. When adding oil or an insecticide, observe the cautions and intervals before harvest on edible crops printed on the insecticide label.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Hazardous if swallowed, inhaled or absorbed through the skin. Avoid contact with skin, eyes and clothing.
