DIRECTIONS Recommendations for the use and dosage of Fixed Copper vary in different sections. Therefore, we suggest that you use Bartlett's Fixed Copper "53" according to the official Spray Calendars issued in your locality. The following general directions are a guide to the use of this material.

FRUITS Sour Cherries: For Leaf Spot, use 2 Kg with 4 Kg of Hydrated Spray Lime per 1000 Litres of water.

Grapes: For Black Rot and Downy Mildew, use 3 Kg with 6 Kg of Hydrated Spray Lime per 1000 Litres of water.

Brambles, Gooseberries and Currants: For Copper Responding Fungus Diseases, use 3 Kg with 4 Kg Hydrated Spray Lime per 1000 Litres of water.

VEGETABLES Potatoes: For Early or Late Blight, use 5 Kg per 1000 Litres of water.

Tomatoes: For Early and Late Blights and Anthracnose, use 4 Kg per 1000 Litres of water.

Cucurbits: (Cantaloupes, Cucumbers, Squash and Watermelons): For Anthracnose, Downy Mildew, Angular Leaf Spot and Scab, use 3 Kg per 1000 Litres of water.

Celery: For Early and Late Blight, use 3 to 4 Kg per 1000 Litres of water.
