Point nozzle upwards, direct the spray mist to all parts of the room especially the windows and other light sources that attract these insects. Fill the room with mist, then leave the treated area. Keep the room closed for 15-30 minutes. Ventilate the room when treatment is complete.

For Wasps: Application should be made late evenings when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

For crawling insects, Cockroaches, Earwigs, Sowbugs, Spiders: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards and storage areas. Spray directly on insects when possible. Repeat as necessary.

For Ants: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

DISPOSAL

When container is empty, press valve to release all remaining pressure. Wrap and dispose of empty container in household garbage.
