DIRECTIONS:

Later's Bugban-C Ant Killer dust is Ready-To-Use and effectively controls Ants, Chinch Bugs, White Grubs and many other insect pests that invade the home and destroy lawns and gardens.

1m = 1 long pace

25 m² = 5m x 5m

HOW TO USE:

As a SPOT Treatment for ANT HILLS:

Apply dust over and around each individual Ant hill.

As a Band Treatment Around the House:

Apply a 15 cm (6 inch) band of this dust next to the foundation of the house to control Home Invading Pests such as Ants, Carpenter Ants, Crickets, Earwigs, Spiders and Sowbugs.

On LAWN: Make no more than 2 applications per season. Sprinkle 500 g evenly over 25m² to control Ants, Chinch Bugs, Sod Webworms and Cutworms. For best results, lawn should be dry and mowed before application. Water the lawn thoroughly after application. For control of surface feeding insects (Sod Webworms) apply in the early evening and withhold watering for 24 hours.

To control European Chafer Larvae, Japanese Beetle Larvae and White Grubs sprinkle 500 g evenly over 12.5 m² and water in.

AROUND ORNAMENTALS: Make no more than 2 applications per season. Sprinkle 500 g evenly over 12.5 m² of soil and water in or mix with soil to a depth of 15 cm. This prevents insect damage and controls pests such as Ants, Crickets, Cutworms, Earwigs, European Chafer Larvae, Japanese Beetle Larvae, Sowbugs, Spiders and White Grubs which destroy leaves and roots.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Keep children and pets off treated areas until watered in and dry. Cats are especially sensitive to chlorpyrifos. Do not allow dust to contact food, food preparing surfaces, utensils or drinking water. Wash contaminated surfaces with soap and water. Avoid contact with dust, it may cause irritation to eyes or skin. Avoid inhaling dust. Wash thoroughly with soap and water after using.

ENVIRONMENTAL HAZARDS:

This product is toxic to fish. Avoid contamination of fish ponds and fish aquaria. Do not use in animal buildings.

FIRST AID:

If swallowed, give 2 glasses of warm water to drink and induce vomiting by inserting finger into mouth and touching the back

of victim's throat. Contact a doctor or poison control centre immediately. Never give anything by mouth to an unconscious person. IF IN EYES, flush with water for 15 minutes and get medical attention. IF ON SKIN, wash with soap and water.

TOXICOLOGICAL INFORMATION:

Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection only is an antidote.

STORAGE: Keep product in original container. Store in a cool, dry place away from food.

DISPOSAL: Do not re-use container. Wrap container and dispose of in household garbage.
