As a sanitizing rinse for dairies, restaurants and food handling equipment: dilute 2 mL/litre with water. Clean area or object with a suitable detergent, rinse well, then rinse in Q4 solution and air dry. To disinfect and deodorize floors, wall fixtures and other hard surfaces, dilute 4 mL/litre with water. Clean area with detergent, rinse, then wash with Q4 solution. For hospital

area disinfection, a dilution of 8 mL/litre is recommended. To deodorize garbage pails or rest rooms, use a 9 mL/litre dilution.

FIRST AID
