INSECTO-MIST

INSECTO-MIST insecticide is designed for use in Automatic Dispensers and releases a metered dose of 55 mg of insecticide at 15 minute intervals. FOR THE CONTROL OF FLIES, MOSQUITOES, GNATS, AND DROSOPHILA IN RESTAURANTS, FOOD PROCESSING PLANTS, MEAT PROCESSING PLANTS, HOSPITALS, DAIRIES, HORSE STABLES, COW BARNs, POULTRY HOUSES AND OTHER AREAS OF AT LEAST 170 M³ OF FREE FLOW AIR SPACE, WHERE THESE FLYING INSECTS ARE AN ANNOYANCE.

DIRECTIONS: AUTOMATIC DISPENSER. Each dispenser is designed to protect an area up to 170 cubic metres for up to 30 days. Remove protective cap from top of can and carefully place can in the

Automatic Dispenser. Suspend dispenser 2 metres from floor at a point where air flow will carry insecticide throughout the area. Do not install directly over food or food packaging surfaces.

CAUTION: In meat packing plants, spray only when plant is not in operation. No exposed meat products, ingredients or packaging materials to be left in room. Cover handling equipment. Any treated surface that may contact meat food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for processing.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not expose to temperature above 50 'C. Do not puncture or incinerate. Remove bird cages and cover fish bowls while areas are being treated. Do not use close to varnished, or polished plastic surfaces. Do not contaminate food, feed, or water troughs. Avoid contact with skin and inhalation of spray mist. Wash after using. Do not contaminate any body of water. Do not use in nurseries or rooms where infants, ill or aged persons are confined.

FIRST AID: In case of contact with eyes or skin, flush with water. If irritation persists, seek medical attention. If accidentally swallowed, call a physician or poison control centre.

DISPOSAL: When container is empty, press valve to release all remaining pressure. Dispose of empty container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer.
