## DIRECTIONS

Remove the sprayer nozzle from the container. Remove lid from container, attach tube to nozzle and attach nozzle to bottle. Attach garden hose to the sprayer nozzle and turn the regulator to the OFF position. The OFF position is when the regulator is pushed back towards the hose. Turn on the water. Facing the

lawn, turn the regulator to the ON position and begin spraying. The ON position is when the regulator is pushed forward. When spraying is comlete, turn regulatory to the OFF position, turn off the water and disconnect hose.

NOTE: 100 sq. metres is approximately 10 paces x 10 paces (1 pace = metre).

LAWNS: MAKE NO MORE THAN TWO APPLICATIONS PER SEASON. Apply when winds are calm. Avoid spray drift. Do not overlap areas already treated. Apply to spray surface evenly. To control chinch bugs, sod webworms, ants, and mosquitoes, apply 250 mL evenly over 100 m2. For chinch bug control, apply anytime between June and September. For the control of ants, treat the nests and surrounding area. For the control of sod webworms, apply anytime between June and September and delay mowing or watering for 12 to 24 hours after treatment.

To control White grubs and the larvae of European chafer and Japanese beetle, apply 500 mL evenly over 100 m2. Treat in late July or August when the grubs are small and feeding on the grass roots just below the soil surface. Immediately after spraying, water the lawn thoroughly.

To control crane fly larvae (leather jackets) apply 250~mL evenly over 100~m2. Treat in late fall after adult crane fly flights have ceased for the year. Immediately after spraying, water the lawn thoroughly.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid inhaling spray mist or contact with eyes, skin and clothing. Use of rubber gloves is recommended. May cause irritation to skin or eyes.
