DIRECTIONS FOR USE:

SHAKE WELL BEFORE USING.

GENERAL: Breaking of urination habits should only be attempted if the area is thoroughly cleaned. This product may not break the established habits of pets unless it is used in conjunction of other training methods. Apply only in areas adjacent to buildings. Do not apply in wildlife habitat areas (e.g., parklands, forested lands).

Directions: **1.** Shake well before using **2.** Stray animals are frequently attracted to areas where urine and feces have been deposited. First, remove any droppings and spray contaminated area. **3.** For best results spray only on ground around plants, shrubbery and trees. **4.** Do not apply directly to flowers or foliage of shrubs or ornamental plants. **5.** Repeat as often as necessary, until pets' habits are broken.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container. Do not store at temperatures over 50°C. Avoid contamination of food, feed, utensils and water. Avoid contact with skin. Wear rubber gloves when applying this product by hand. Do not apply this product in a way that it will contact any person or pet, either directly or through drift. Do not apply to food/feed crops or animals. Do not allow persons or pets to enter the treated area until the spray has dried.
