## USE DIRECTIONS:

FOR CLEANING: Lightly soiled areas - surfaces to be cleaned should be mopped or brushed with a solution containing 4 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water. Rinse cleaned area with fresh water. Heavily soiled areas - mop or brush soiled surface with a solution containing 12 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water. Rinse cleaned surface with fresh water.

GENERAL PURPOSE DISINFECTION: To disinfect walls, floors, and other hard surfaces in schools, rest rooms and other public areas mop or brush surface to be treated with a solution containing 4 mL of AG- SERVICES INC. Disinfectant Cleaner Deodorant per litre of water. Surfaces that are heavily soiled should be cleaned with 16 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water and then disinfected.

FOOD AREA DISINFECTION: To disinfect hard, non-porous surfaces, add 8 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water. Those surfaces which may later come in contact with food must be rinsed with clear water of drinking quality.

HOSPITAL DISINFECTION: To disinfect walls, floors, furniture and other hard surfaces in hospitals and nursing homes, mop or brush surface to be treated with a solution containing 8 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water. Those surfaces that are heavily soiled with blood, fecal material or exudates should be thoroughly cleaned with a solution containing 16 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water and then rinsed with a fresh solution containing 8 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water.

DEODORIZATION: To deodorize surface during cleaning, mop or brush surfaces with a solution containing 8 mL of AG-SERVICES INC. Disinfectant Cleaner Deodorant per litre of water, an effective antibacterial cleaner designed for use in industrial and institutional cleaning. When used as directed, AG-SERVICES INC. Disinfectant Cleaner Deodorant will disinfect hard surfaces, such as floors, walls, counter tops and furniture. It may be relied upon to deodorize bathroom areas, garbage pails, garbage shutes in apartment buildings refuse holding bins, refuse storage areas. AG- SERVICES INC. Disinfectant Cleaner Deodorant can also be used for kennel areas, and similar areas where obnoxious odours may develop.

GENERAL INFORMATION: In using AG-SERVICES INC. Disinfectant Cleaner Deodorant it is desirable for the user to allow solutions to remain in contact with the treated surfaces; that is allow them to remain wet for a period of time (usually about 15 minutes) to get full benefit from the antimicrobial action. Food surfaces in particular should be treated in this manner. In some cases heavily soiled areas should be cleaned, then retreated to achieve this result.
