DIRECTIONS FOR USE

ONCE-THROUGH INDUSTRIAL COOLING WATER SYSTEMS: For the control of algal, bacterial and fungal slimes in once-through and

closed-cycle fresh and sea water cooling systems; cooling ponds, and lagoons; add Bromo-Tabs to the system inlet water or before any other contaminated area in the system. Each tablet weighs 20 gm.

RECIRCULATING COOLING WATER SYSTEMS: When used as directed, Bromicide effectively controls algal, bacterial and fungal slimes in commercial and industrial cooling towers; influent water systems such as flow through filters, and lagoons; heat exchange water systems, industrial water scrubbing systems; brewery pasteurizers; and industrial air washing systems equipped with a mist eliminator.

DOSAGES RATES: Initial Dose. When system is noticeably fouled, add $1.0-3.0~\mathrm{kg/10,000}~\mathrm{L}$ of water contained in the system. When microbial control is evident, add $0.5-1.50~\mathrm{kg/10,000}~\mathrm{L}$ of water contained in the system. Repeat as needed to maintain 1mg/L halogen residual, measures as free chlorine, for at least 4 hours.
