For use as a spot or crack and crevice treatment to kill spiders, sowbugs, earwigs, cockroaches, crickets, millipedes, silverfish, ants, fleas, carpet beetles, brown dog ticks, cluster flies, house flies.

GENERAL DIRECTIONS:

Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. If reinfestations occur, repeat applications as necessary. Provide adequate ventilation after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.

INDOOR USE: Thoroughly treat cracks and crevices and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of

floors under floor coverings and other places where insects hide or are seen.

OUTDOOR USE: Spot Treatment: Spray outside surfaces of screens, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter. The cluster flies and house flies will be killed when they land on the treated surfaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin or clothing. DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOOD STUFF, FOOD UTENSILS, FISHBOWLS OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. Do not use in areas where food is handled, prepared or stored. May cause skin and/or eye irritation. Product is very toxic to fish. Do not contaminate water by improper use or disposal. Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C.
