DIRECTIONS FOR SWIMMING POOL CHLORINATION:

WATER PURIFICATION:

Add daily to maintain 1.0 - 3.0 parts per million of residual available chlorine (PPM CL₂). Daily charge depends upon air temperature, number of people in the pool and rain. These conditions may require higher rates to maintain proper chlorine residuals. Superchlorinate weekly with 1 litre per 10,000 litres when average daily temperature is 25°C - 32°C, otherwise superchlorinate every other week.

TOTAL DAILY USAGE LITRES OF WATER

125 - 250 mL	10,000 L
250 - 500 mL	20,000 L
625 mL - 1.25 L	50,000 L
1.25 L - 2.50 L	100,000 L
3.25 L - 6.25 L	250,000 L

ALGAE: Add 2 litres for every 10,000 litres of water and circulate for at least 8 hours. If algae persists, superchlorinate by adding 3 litres/10,000 litres of water (every two weeks in hot weather). Do not use pool until available chlorine has fallen to below 2.0 PPM CL₂ Vacuum pool when dead algae settles.

PH CONTROL:

Use of test kit is recommended (Chlorine & PH). Test PH of water. A PH of 7.2 to 7.8 is acceptable. Add muriatic acid if HIGH. Add soda ash if LOW.

TOTAL ALKALINITY CONTROL:

Use of a test kit is recommended (total alkalinity). Test T.A. of water. A TA of 100 to 125 PPM is acceptable. Add muriatic acid if too HIGH. Add sodium bicarbonate if too LOW.

WADING POOLS:

Add 5 mL for every 100 litres of water daily. Chlorinate to maintain daily chlorine residual of 3 - 5 PPM.

CAUTION:

KEEP OUT OF REACH OF CHILDREN. Avoid contact with skin and eyes. Do not mix with toilet bowl cleaners, rust remover, household ammonia or acids. DO not mix with any other chemicals.

FIRST AID TREATMENT:

Contains Sodium Hypochlorite. If splashed in eyes or on skin, flush thoroughly for 15 minutes with water. For eye contact, get medical attention. Harmful if swallowed, give one or two glasses of milk or warm water. Call Physician immediately. Keep patient warm.

STORAGE:

Keep out of sunlight and store in cool place with container closed. Rinse container thoroughly before discarding to dispose of chemical. Flush into sewer with large quantities of water.
