To kill all flies in the milk parlor close doors and windows. At a rate of 200 mL per 100 m³, spray upward in a sweeping motion

until room fills with mist. Keep room closed for 15 minutes and then ventilate. Cover or remove any milking equipment before spraying, cover bulk tank loading and unloading valves. Wash all food processing equipment with potable water before resuming operation.

PRECAUTIONS:

KEEP OUT OF THE REACH OF CHILDREN.

Do not inhale spray mist. Remove animals before treatment. Avoid contact with skin. Wash after using. Avoid contamination of feed and water troughs. Avoid inhalation. Do not use in rooms where milk is processed handled or stored

CONTENTS UNDER PRESSURE:

Do not puncture or incinerate. Do not store at temperature above 50 °C or near an open flame. Do not contaminate any body of water.
