DIRECTIONS:

For heavily bio-fouled systems use 0.25-0.75 kg/10,000L of total system. Repeat initial dosage until 1 ppm bromine residual is maintained for 4 hours. When system is under control use 0.13-0.37 kg/10,000L of total system.

ECOLOGICAL:

Open dumping is prohibited. Do not contaminate water, food or feed by disposal or storage.
