#### DIRECTIONS

Apply "DISVAP BUG KILLER" on appearance of insects. Repeat at 7-10 day intervals or as necessary. For cabbage looper control repeat at 5-7 day intervals. Do not use in heavy winds.

#### PRECAUTIONS

Do not breathe dust. Do not take internally. Avoid unnecessary skin contact. Wash hands after using. Wear regular long-sleeve work clothing. Change to clean clothing daily. Do not contaminate streams, ponds and water supplies.

Keep out of reach of children and animals. Do not use where bees are foraging. Protect bees from treated area for one week after treatment.

Dispose of empty container by burying or send to garbage dump in accordance with Municipal regulations.

#### LIMITATIONS

Some leaf injury may occur to cucurbits and cruciferae if treatments are made when tender foliage is wet or in the presence of prolonged high humidity.

#### FIRST AID

If swallowed, cause vomiting and get medical aid. If in eyes, flush thoroughly with plenty of water.
