GENERAL INFORMATION

Apply INSECTA to interior surface as described below to reduce infestation of insects.

INSECTA may be applied with a brush (10 cm band) or spray (10 cm band) or as a crack and crevice application to control insects on non-food contact latex painted interior surfaces in manufacturing plants, warehouses, hotels, horse barns, dairy barns, dog kennels and other buildings. Use as is, do not dilute. Stir well before use. Covers 15 square meters per litre.

Apply utilizing a coarse, low pressure spray (20 psi or less) as a crack and crevice application or as a 10 cm band barrier application at entranceways and where the walls and floors meet. Dries quickly and rinses easily with water. Allow to dry for several days before washing. Wash brush, roller or spraying equipment thoroughly with soap and water after use. Contact between insect and the treated is necessary, so any time the surface becomes covered with dust or dirt it should be washed with water in order to re-establish maximum possible contact.

Using INSECTA as a normal maintenance treatment may reduce the need for using topical insecticides directly on dogs and cats. INSECTA applied on exposed glass, glazed tiles, metal or other non-porous surfaces may dry leaving a light film. DO NOT USE AS A SPACE SPRAY.

#### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

PRECAUTIONS: Harmful if swallowed or absorbed through skin. Avoid breathing vapours while wet. Provide adequate ventilation during application. Avoid contact with eyes, skin and clothing. In case of contact, flush eyes or skin with plenty of water. Once this product is applied, use plastic gloves to remove applicator, rinse and seal in plastic container until re-use or disposal.

ENVIRONMENTAL AND PHYSICAL HAZARDS: This product is toxic to fish, birds and other wildlife. Do not contaminate water by cleaning of equipment or disposal of waste. Do not apply directly to water. Apply this product only as specified on this label.

STORAGE: Store away from freezing temperatures.
