DIRECTIONS:

BIOMATE 6264 should be slug fed at intervals described by your Dearborn Consultant. Metalworking Cutting Fluids: BIOMATE 6264 is recommended for soluble and emulsifiable type aqueous metalworking fluids (natural and synthetic). BIOMATE 6264 should be added to the system at a point of good agitation once or twice per week for biological control. Normal dosages will vary between 500 and 1000 ppm.

ECOLOGICAL:

Open dumping is prohibited. If plastic, do not reuse empty container. This product is toxic to fish and wildlife. Treated effluent should not be discharged where it will drain into lakes, streams, ponds or public water. Do not contaminate water by cleaning of equipment or disposal of waters. Apply this product only as specified on this label.
