DIRECTIONS:

Chloropicrin evaporates into tear gas self announcing even at very low concentrations.

INSIDE FUMIGATION:

Seal all windows, lock doors and post warning signs. Wear full face gas mask with canister for organic vapours. Dosage: 2 to 2.5 kg of fumigant to 100m³. In loaded vaults increase dosage by about 1.5 kg per 100m³. Application: Pour fumigant onto sacks throughout building. Leave for 24 hours. Ventilate thoroughly before re-use.

RODENT CONTROL:

Have building as warm as possible. Seal outside burrows to

prevent rodents from leaving the building. Dosage: For mice & rats - 2.5 to 4 kg fumigant per 100 m³. Application: Pour approximately 750g of fumigant onto a crumpled burlap sack which has been placed in a tray. Place trays around perimeter of building. Keep building closed overnight and ventilate next morning for several hours. Burrows: To treat burrows in farm yards, fields and other areas, pour 15 mL onto wad and stuff into burrow and seal hole with earth.

PRECAUTIONS

Remove top of can only in open air. Do not breathe vapour. Do not get in eyes, on skin or clothing.

FIRST AID

In case of contact wash skin and eyes, flush with water for 15 minutes. For eyes get medical attention. Remove and wash contaminated clothing.

TOXICOLOGY

If inhaled get patient into open air. Lie down, keep warm and quiet. Call a physician immediately. Keep away from children.
