NON-GAS AEROSOL. Delivers a quiet, even spray without using CFC or hydrocarbon propellents. All net contents are available for use, unlike a normal aerosol where a large percentage is propellent that is lost to the atmosphere and serves no other purpose than propelling product from the container.

Container can be held in any position while spraying, even upside

down allowing you to reach all parts of the animal being treated. The spray delivered is quiet so as not to frighten the animal being treated. The product is non-chilling and non flammable.

DIRECTIONS: Shake well before using then remove cap. FOR FLEA & TICK CONTROL. Hold can 25-30 cm from pet and spray evenly to lightly dampen coat over entire body beginning at head and working towards the tail. Pay special attention to neck and hindquarters. Do not spray face, eyes or genitals. As you spray, fluff the hair so that spray will penetrate to the skin but spray only until hair is damp -- not wet. Apply as evenly as possible because fleas will migrate to untreated areas (e.g. toes, foot pads, around ears). Do not soak animals. Comb and brush into coat. Spray ticks directly. Also spray bed and living quarters if needed Repeat as necessary. Do not use on puppies or kittens under 8 weeks of age, or nursing females. Consult veterinarian before use on pregnant animals. Do not use on sick animals or animals under drug or other pesticide treatment. For effective flea and tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpet, and furniture (discard vacuum bag after use) and wash the pet 's bedding, living quarters and surrounding areas. If pest problem persists an insecticidal premise treatment may be required.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not heat, puncture or incinerate container. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperature over 50 C. Do not spray in eyes, or face, or on genitals of pet. Discontinue use if dermal or nasal irritation develops. Do not use near fish, food, or foodstuffs. Avoid skin contact by wearing rubber gloves. Wash hands with soap and water after spraying.

FIRST AID: In case of contact with skin wash thoroughly with soap and water. If sprayed in your eyes, flush with clean water. If irritation persists, obtain medical attention. If accidentally swallowed, contact Physician or Poison Control Centre immediately.

DISPOSAL: When container is empty, press button to release all pressure. Wrap and dispose of empty container in regular household garbage.
