GENERAL INFORMATION

MOUSE-BUSTER Mouse Killer is specifically designed to be used for the control of house mice in and around homes. This ready-to-use product is designed for use in areas where mice have been seen and that are in proximity to places frequented by children and pets, or where food is prepared or stored. The MOUSE-BUSTER Mouse Killer may be dispensed by building owners, pest control operators, custodians and other personnel to assist in mouse control programs.

DIRECTIONS FOR USE

This product is not refillable and no attempt should be made to open the MOUSE-BUSTER Mouse Killer. DO NOT ALLOW CHILDREN TO PLAY WITH THE MOUSE KILLER, EVEN WHEN EMPTY. Check the contents frequently and replace the units as needed. Secure one MOUSE-BUSTER Mouse Killer every 3-4 meters along walls where mouse activity has been noticed. Dispose of dead mice and empty Mouse Killers properly (see "DISPOSAL" statement). To prevent reinfestation, eliminate food, water and shelter as much as possible. Do not place the MOUSE-BUSTER Mouse Killer in direct sunlight or in direct proximity to heating devices such as registers, wood burning stoves, baseboard heaters, heating vents, etc. in order to prevent melting of the bait block.

PRECAUTIONS

The bait contained within the MOUSE-BUSTER Mouse Killer may be harmful or fatal if swallowed. Keep loose bait away from humans and domestic animals, wildlife and pets. Do not use the Mouse Killer if bait appears loose, and if loose bait is observed within the Mouse Killer dispose of the baiter in accordance with the "DISPOSAL" statement. TOXICOLOGICAL INFORMATION

The bait in this product contains brodifacoum, a vitamin $\rm K_1$ inhibiting anticoagulant. Severity of poisoning may be evaluated by monitoring prothrombin time. Vitamin $\rm K_1$ is antidotal. - 2. Secure one MOUSE-BUSTER Mouse Killer every 3-4 meters along a wall in these areas by removing the protective backing on the tape and by pressing the unit on to a clean dry surface. The best placement is in house out-of-the-way locations and tight areas that mice like to hide in and use for shelter.
- 3. Monitor consumption of bait within the unit and when the MOUSE-BUSTER Mouse Killer is found empty, replace with another Mouse Killer unit. Continue placement of the Mouse Killer units until all signs of mouse activity has ceased.
- 4. RETAIN CARTONETTE TO ACCESS INFORMATION IN CASE OF EMERGENCY.
