For best results, use an OTRHO SPRAY-ETTE Garden Hose Sprayer.

FOR USE ON: Roses, Camellias, Azaleas, Gardenias, Hibiscus, Evergreens, Shade Trees and other Ornamentals. Use 30 mL (2 Tablespoons) per 5 L of water to control Aphids, Red Spiders, Armyworms, Certain Caterpillars, Chrysanthemum Sly, Diabrotica Beetles, Earwigs, Elm Leaf Beetles, Flea Beetles, Cucumber Beetles, Grasshoppers, Lace Bugs, Box Elder Bugs, Leafhoppers, Leaf Miners, Leaf Rollers, Thrips, Mealy Bug, Plant Bugs, Psyllids, Rust Mite, Saw Fly Larvae, Scale(Crawlers), Spittle Bugs, Sowbugs, White Fly, Wooly Aphid, Rose Chafer.

Apply as pests appear. Repeat as necessary or at two week intervals.

For use around Homes, Lawns, Patios and Garbage Cans use 50 mL (3 Tablespoons) per 5 L of water to control Clover Mites, Ants, Black Widow Spiders, Crickets, Sowbugs, Earwigs, Box Elder Bugs.
