**DIRECTIONS**

PYRIBAN 25E is an emulsifiable concentrate which can be diluted with water.  
For 0.25% solution dilute 10mL PYRIBAN 25E in 1 Liter water (1 part to 99 parts).  
For 0.5% solution dilute 20mL PYRIBAN 25E in 1 Liter water (1 part to 49 parts).

Mix only 1 days requirement at a time.

#### **PESTS INDOORS**

Use PYRIBAN 25E by applying as a 0.25% or 0.5% Chlorpyrifos spray. Use the 0.25% spray to control light infestations and the 0.5% spray to reduce quickly heavy infestations or as directed.

This product is to be used ONLY in the following areas in structures:

Crack & Crevice in Ship holds, Railroad Boxcars, Industrial plants, Manufacturing plants, Warehouses, Meat packing plants, Food processing plants. In food processing areas use only during close down periods.

Spot treatment in Industrial plants, Manufacturing plants, Warehouses, Meat packing plants, Food processing plants.

Use as a spot treatment to control **Cockroaches, Ants, Crickets, Firebrats, Silverfish, Spiders** in and around both food and non-food areas by application as a coarse, low pressure (150 kpa or less) spray to localized areas where these pests have been seen or as suspected of hiding or entering. Apply only enough spray to cover thoroughly the surfaces treated using special care to avoid unnecessary runoff. Do NOT introduce the spray into the air or allow the spray to contact food or food-contacting surfaces. Areas treated may include dark corners of rooms and closets; along and behind baseboards; beneath and behind stoves, refrigeration units, and similar food preparation areas and equipment, floor drains, and around plumbing and other utility installations. For **Ants** apply to Ant trails and wherever these pests may find entrance. Spot treatment may encompass crack and crevice treatment by applying small amounts of material directly to openings leading to voids and hollow spaces in walls, equipment legs and bases or at points between different elements of construction or between equipment and floors. The use of chlorine based cleaning materials will reduce significantly the residual effect of PYRIBAN 25E. Repeat treatment as needed by not more often than once every 7 days in restaurants and similar establishments or more often than every 14 days in other types of food handling establishments. In case of emergency (call back), PYRIBAN 25E may be applied after 2 days from last treatment but emergency use should be limited to once per month.

Remove or cover all food, packaging materials, and utensils before spraying. After spraying wash all surfaces that may contact food and rinse thoroughly with potable water before re-use for food processing. Applications of this product in food handling establishments other than as a spot and/or crack

and crevice treatment are NOT permitted.

**NOTE:** A period of 4 to 7 days is normally required for maximum effect on **Cockroaches**. Do NOT apply in dwellings where occupants are ill or pregnant.

KEEP OFF TREATED SURFACES UNTIL THE SPRAY HAS DRIED.

#### **PESTS OUT-OF-DOORS**

Use PYRIBAN 25E to control certain pests of lawns and around buildings.

#### **PEST CONTROL AROUND NON-RESIDENTIAL BUILDINGS:**

This product is to be used in the flowing areas around structures:

**Ants, Crickets, Earwigs, Millipedes, Sowbugs, Pillbugs:** To help prevent infestations of buildings treat a band of soil 2-3 meters wide around and adjacent to the building foundation to a height of 50 cm to 1 meter or use a spot treatment where pests are active and may find entrance. For each 100 sq. meters to be treated dilute 45 mL PYRIBAN 25E in enough water to obtain complete and uniform coverage and apply as a coarse spray to wet thoroughly the band area.

**Bees, Box Elder Bugs, Carpenter Ants, Cluster Flies, Hornets, Spiders, Wasps:** Use a 0.5% spray. Spray localized areas on outside surfaces of industrial plants, manufacturing plants, warehouses, meat packing plants, food processing plants. Apply spray by hand held, backpack or hydraulic sprayer to nesting sites and other localized areas where pests congregate. In order to minimize drift, apply a coarse spray wetting thoroughly the surface but NOT allowing runoff to occur. This can be achieved best by utilizing low gun pressures to generate large droplets. Avoid repeat applications at intervals of less than 50 days.

**TURF PEST CONTROL:** Golf Courses, Industrial sites, Highway medians and Sod Farms

**ORNAMENTALS:** (commercial production only) - Greenhouses, Nurseries, Industrial sites.

**Ants, Chinch Bugs, Cutworms:** Spray when pests first appear, using 44 mL PYRIBAN 25E in sufficient water to cover 100 sq. meters.

**Sod Webworms:** Mix 44 mL PYRIBAN 25E in sufficient water to cover 100 sq. meters. Delay watering or mowing the treated area for 12 to 24 hours after treatment.

Do NOT allow spray to come in contact with Azaleas, Camellias, Poinsettias, Rose bushes, Geraniums, Oxalis, Coleus or variegated ivy because of possible injury to these plants.

**PRECAUTIONS.** KEEP OUT OF REACH OF CHILDREN. DO NOT USE IN FOOD PREPARATION SERVING OR STORAGE AREAS. Keep off treated areas until product is dry. May be fatal if swallowed. May be fatal if absorbed through skin. Do NOT apply water-base sprays in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. Note: Water based sprays may stain finished surfaces. Do NOT treat such materials. DANGER - Eye irritant. Causes substantial but temporary eye injury. Do not get in eyes, on skin or clothing. Avoid breathing vapors and spray mist. Wear protective clothing, chemically resistant gloves and chemical worker's goggles when handling. Wash thoroughly with soap and water after handling and before eating or smoking. Remove contaminated clothing and wash before re-use. Discard contaminated leather articles including shoes. Handle concentrate in a ventilated area.

**FIRST AID:** This product contains petroleum distillate. If swallowed, do not induce vomiting. Keep at rest. Get prompt medical attention. If on skin, wash thoroughly with soap and water. If in eyes, flush with running water for 10 minutes. If irritation persists, seek medical attention. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGY:** The decision whether to induce vomiting or not should be made by an attending Physician. If lavage is performed, suggest endotracheal and/or oesophageal control. Danger from aspiration must be weighed against toxicity when considering emptying the stomach. If burn is present, treat as thermal burn, after decontamination. Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine, only by injection is the preferable antidote. Oximes, such as Pralidoxime Chloride, may be therapeutic if used early; however use only in conjunction with Atropine. Supportive care. Treatment based on judgment of the Physician in response to reactions of the patient.

**DISPOSAL AND DECONTAMINATION:** Triple or pressure rinse the empty container thoroughly and add the rinsings to the spray tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use and

dispose in accordance with provincial requirements. For information on the disposal of unused, unwanted product contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

This control product is to be used only in accordance with the directions on this label. It is an offense under the Pest Control Products Act to use a control product under unsafe conditions.
