DIRECTIONS:

This package contains one resin vaporizer strip impregnated with dichlorvos insecticide, in a sealed pouch to prevent vapour loss. For use, remove the strip from the pouch and suspend with the accompanying cage and hook in an enclosed space of up to 30 cubic metres. When the cage is adjusted to its "open" position, the strip gives off a virtually odourless insecticidal vapour which will provide control of flies, mosquitoes and other small flying insects for up to four months. The strip is NOT designed to repel or kill insects instantly nor will it function while the cage is in its "closed" position. Allow free air movement but hang strips away from open windows and doors where excessive ventilation may reduce efficiency. Strips should be at least 3 metres apart. Dispose of empty package and used strip in the garbage.

#### USES:

For use in animal and farm buildings, milk rooms, homes, cottages, cabins, trailers, tents, attics, basements, garbage storage areas and containers, kennels, motels, restaurants, food processing plants, industrial and commercial locations, and similar enclosed spaces.

#### HOW TO ASSEMBLE ON/OFF HOLDER

##### DIAGRAM

- 1) Press outer edges of holder (A) to form as shown. Push out hanging tab on top flap and fold locking edges down before forming top. Fold over top flaps and engage locking edges firmly into holder. Do not attempt to open top once it has been locked.
- 2) Cut open envelope (B) with scissors. Remove INSECT STRIP and place inside holder through open bottom. Fold down locking edges, form and lock bottom of holder. Do not allow the strip to touch textiles or painted surfaces - it may stain.
- 3) Press outer edges to form sleeve (C), and slide it down over the holder containing the strip. Move sleeve up or down to open or close holes of the holder. The INSECT STRIP can be seen through the round holes in the holder when in the open position.
- 4) To hang unit, attach metal hanger (D) to the tab on top of holder.

When flying insects are a problem, place the holder in its open position by aligning the holes of the outer sleeve with those of the inner cage. The holder may be closed when flying insect control is not needed.
