### DIRECTIONS

DAIRY CATTLE, BEEF CATTLE, HORSES: For the control of face flies thoroughly mix 5 mL of Sanex Vapo 20 Emulsifiable Insecticide with 85 mL of water and 85 mL of corn syrup. Apply 5.5 mL of this bait to the forehead of each animal by dipping a paint brush in the mixture and making a single 15 cm stroke on the forehead.
