DIRECTIONS FOR USE

COOLING WATER SYSTEMS: For the control of algae, bacteria, and fungi in Commercial and Industrial cooling water systems, add FORMULE TEGAL 673 as follows:

Initial dose: 20-120 mL per 1,000 L water in the system. Maintenance dose: Every 1 to 5 days or as needed, 6.4 - 40 mL per 1,000 L of water in the system.

DISPOSAL:

- 1. Rinse the emptied container thoroughly and add the rinsings to the treatment site.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
- 3. Dispose of the container in accordance with provincial requirements.
- 4. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environment Canada.
