BROILER BARNS/FLOOR RAISED PULLETS

SPREAD AROUND THE INSIDE PERIMETER OF THE BARN IN A CONTINUOUS STRIP ONE METER WIDE AND 2 mm DEEP, USING A FERTILISER SPREADER. PAY PARTICULAR ATTENTION TO DOOR-WAYS AND SUPPORT POSTS. COVER WITH LITTER. MAY ALSO BE PLACED INSIDE CAVITY WALLS WHEN INSULATING BUILDINGS.

DIRT-FLOORED POULTRY FACILITIES

COVER ENTIRE FLOOR AREA WITH A LIGHT (2 mm) DUSTING BEFORE

PLACING LITTER ON FLOOR.

SEVERE INFESTATIONS MAY REQUIRE THE INITIAL USE OF A QUICK-KILL INSECTICIDE TO OBTAIN IMMEDIATE RESULTS.

BREEDER HOUSING

MAY BE USED UNDER SLATS TO CONTROL DARKLING BEETLE INFESTATIONS IN MANURE.
