Process B 2011 Solution should be used at 0.6-1.0 kg per tonne of dry paper produced at least once per day.

**Metal Working Fluids:**

Process B 2011 Solution should be injected at 5-10 kg per 10,000 liters of system volume.

**Preservative:**

Process B 2011 Solution should be used at the rate of 0.1-0.5% for bacterial control in Latex Emulsions, Polymer Latices, Adhesives.

**Oilfield Applications:**

Inject continuously at 100 ppm active ingredient based on water content of system until control is achieved. Maintenance dosage 10-25 ppm.

**FIRST AID:**

If splashed in eyes or on skin, flush thoroughly with water for 15 minutes.

For eye contact, get medical attention IMMEDIATELY.

If on clothes, remove clothes immediately.

If breathed in, move person to fresh air.
