"Duratrol" Household Flea Spray is a microencapsulated formulation for the residual control of dog and cat fleas and American and brown dog ticks. The microcapsules provide a "timed release" mechanism for the chlorpyrifos active ingredient to provide up to 90-day control of adult fleas and larvae. Also kills many other household insects (see Directions for Use).

DIRECTIONS FOR USE SHAKE WELL BEFORE AND DURING USE DO NOT USE AS SPACE SPRAY. Use of this product is limited to CRACK and CREVICE and SPOT spraying only.

Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose. Mop hard floors. Pet bedding should be washed or replaced with clean, fresh bedding prior to treatment. Adjust sprayer to deliver a coarse wet spray to infested areas. Thoroughly treat cracks, crevices, along baseboards and as a SPOT TREATMENT ONLY to areas of floors and floor coverings and pet resting quarters where fleas and ticks may be present. DO NOT TREAT PETS WITH THIS PRODUCT. DO NOT USE ON BEDDING FOR PUPPIES

AND KITTENS LESS THAN 12 WEEKS OLD. Spray with a smooth back and forth motion to deposit product uniformly. It is not necessary to soak the treated surface, but an even treatment is desirable. Noticeable flea reductions will be observed within 24 hours. This application may reduce the need for the use of topical insecticides to your pet.

To treat other household pests: Including ants, carpet beetles, centipedes, cockroaches, crickets, earwigs, millepedes, silverfish, sow bugs, spiders, ticks and water bugs, direct spray to those areas where pests are found.

NOTE: For spot treatment of floor coverings, a sample of fabric covering or carpeting should be tested carefully for staining prior to spraying.

APPLICATION RATES: 12.5mL/m² (1.2 sq.yds.) - Light to moderate infestations
25 mL/m² (1.2 sq.yds.) - Severe infestations

PRECAUTIONS: Hazard to Humans and Domestic Animals: Avoid breathing spray mist. Avoid contact with skin and eyes. Wash hands after handling and before eating. Do not spray directly on pets or humans. Keep children and pets out of treated areas until spray has dried. Avoid contamination of food and food utensils. Do not use in food preparation areas of commercial establishments. Do not use in serving areas while food is exposed. Do not use in nurseries or rooms where infants, ill or aged persons are confined.

Remove birds from areas being sprayed until completed. Cover fish aquariums and turn off filter while spraying. Use with caution around house plants.

Environmental Hazards: This product is toxic to fish, wildlife and birds. Keep out of any body of water. Do not contaminate lakes or streams by cleaning of equipment or disposal of wastes.

FIRST AID IF SWALLOWED: Call physician or Poison Control Centre. Drink 1 or 2 glasses of water and induce vomiting by touching finger to back of throat. Never give anything by mouth to an unconscious person. IF ON SKIN: remove contaminated clothing and wash skin with soap and water. IF IN EYES: flush eyes with plenty of water. If irritation persists, call physician.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor, treat symptomatically. Atropine only by injection is an antidote.

STORAGE: Store in original container out of the reach of

children. Do not freeze or store above 66°C.

Do not contaminate water, food or feed by storage or disposal. Do not reuse container. Dispose in a safe place according to provincial regulations.

NOTICE TO USER: This control product is to be used only in accordance with the directions on this label. It is an offense under the Pest Control Products Act to use a control product under unsafe conditions.
