DIRECTIONS FOR USE:

For the preservation of exterior seasoned wood products: - For exterior use only. Not for use in dwellings. - For above ground use only. Apply to the wood surface only by brush for on site field applications. - For industrial use only in commercial spraybox, flow coating or dip tank. Equipment must be free of leaks. Equipment

must have provision to eliminate or contain mist, overspray, drips and spillage into the surrounding environment. - Use of this product in industrial settings requires adequate engineered ventilation and containment in the treating area and in the area where wood is dried. - Do not use the preservative or treated wood where Copper Naphthenate may contaminate food, feed or drinking water. May be used in greenhouse and garden timbers in contact with non-food producing plants only. Carrier solvent must be allowed to dry thoroughly before introducing plants to prevent phytotoxicity. For Fabric Use: For use only on exterior industrial fabric, duck cloth, awnings, etc. - Do not use on rubber lined fabric. - Not for use on fabrics which may come into prolonged contact with skin.

#### PRECAUTIONS:

Avoid breathing concentrated vapour. Harmful if swallowed or inhaled. Use a cartridge respirator appropriate for the job conditions, e.g., poorly ventilated areas. - Wear rubber or plastic gloves and appropriate covering clothing when applying this product. - Use goggles in case of splash hazard. - Flammable. Do not use or store near open flame or spark, or in areas subject to excessive heat. - Keep out of reach of children and animals. - Do not contaminate bodies of water. This product is toxic to fish.

#### FIRST AID:

If swallowed, do not induce vomiting. Call physician immediately. - If splashed in eyes, flush with clean water for 15 minutes and contact a physician. - In case of skin contact, remove the product from the skin promptly by washing with hand degreaser and then with soap and water.
