DIRECTIONS FOR USE: Open package and remove single towelette. Reseal package tightly after removal. Immediately unfold Towelette and wipe a thin uniform film over all exposed skin. **DO NOT APPLY TO EYES AND MOUTH.** Do not apply to hands of young children. Use just enough repellent to cover exposed skin and clothing. For Ticks and Chiggers (mites) apply to shoe tops, socks and areas around openings in clothing. Do not use under clothing. Avoid over exposure. Frequent re-application is not necessary for the product to work effectively. Repeat application when effectiveness diminishes by using a fresh towelette. After returning indoors wash treated skin & clothing with soap & water.
