FIRST AID

DIRECTIONS FOR USE:

To install or replace the Mega-Catch™ Octenol Fragrance Strip into the Mega-Catch™ Mosquito Trap:

1. Ensure the power to Mega-Catch™ Mosquito Trap is disconnected.
2. Remove the Mega-Catch™ Octenol Fragrance Strip from its pouch and be careful not to touch the exposed holes on its surface.
3. Place the strip in one of the slots in the base of the trap and then reconnect the power.

Mega-Catch™ Octenol Fragrance Strip should be effective for up to 30 days depending on weather conditions.

STORAGE AND DISPOSAL:

Mega-Catch™ Octenol Fragrance Strip Storage: Store in original container in a cool, dry area and out of reach of children until ready to use.

Mega-Catch™ Octenol Fragrance Strip Disposal: DO NOT reuse the spent lures. Dispose in household garbage. Unused or partially used products should be disposed of at provincially or municipally designated waste disposal sites.
