DESCRIPTION

When used as directed, this product will kill the following microorganisms: Staphylococcus aureus, Salmonella choleraesuis, Pseudomonas aeruginosa, Streptococcus faecalis, Salmonella typhosa, Escherichia coli, Trichophyton interdigitale, (athlete's foot).
