NOTICE TO USER: This control product is to be used only in accordance with the directions on this label. It is an offense under the Pest Control Products Act to use a control product under unsafe conditions.

DIRECTIONS FOR USE: To be used only in the manufacture of non-food use/non-food contact pesticides which are registered under the Pest Control Products Act.

PRECAUTIONS: Post a copy of this label in the formulating or repackaging area.

Keep out of reach of children. Toxic if swallowed. May cause severe skin or eye irritation. Avoid contact with skin, eyes and clothing. Wear gloves impervious to creosote at all times.

Do not carry, store, or consume food or drink in areas where creosote is stored or used, or where freshly treated wood is stored. Do not carry or smoke cigarettes in working areas. Do not expose cuts or abrasions to creosote solutions. Get immediate first aid if eyes contact creosote solutions. Keep work area well ventilated. Keep away from open flame.

Do not get in eyes, on skin or on clothing. Do not breathe vapors or spray mist. Use with adequate ventilation. Do not take internally. Wash thoroughly after skin contact, before eating, drinking, use of tobacco products, or using restrooms.

Avoid inhaling vapors. If inhalation of vapors cannot be avoided, applicators must wear a properly fitting, well-maintained half-mask canister or cartridge respirator which is MSHA/NIOSH-approved for polynuclear aromatics and organic vapors.

Formulators must wear protective clothing (including overalls, jackets, gloves, boots and head covering) impervious to the wood treatment formulations, a properly fitting, well-maintained canister or cartridge respirator which is MSHA/NIOSH approved for polynuclear aromatics and organic vapor, and goggles.

Formulators must wear gloves impervious to the wood treatment formulation in all situations where dermal contact is expected.

Protective clothing, workshoes or boots and equipment must not be taken home.

Formulators engaged in loading, cleaning or maintenance of the equipment or other activities which may result in exposure to liquids, splashes or spills, must wear long-sleeved shirts, long pants, an impermeable apron, eye protection (chemical goggles), impermeable gloves/boots, and a well-maintained canister or

cartridge respirator.

Wash exposed skin thoroughly after contact with treated wood and before eating, drinking or using tobacco products.

Protective clothing must be changed when it shows signs of contamination. Dispose of worn-out protective clothing and workshoes or boots in accordance with Provincial requirements.

Formulators must not eat, drink or use tobacco products during those parts of the application process that may expose them to the wood treatment formulation.

NOTE TO USER: As used on this label, the term "respirators" means properly fitting, well-maintained, half-mask canister or cartridge respirators which are MSHA/NIOSH-approved for polynuclear aromatics and organic vapors. Examples of acceptable materials for protective clothing (e.g., gloves, overalls, jackets, and boots) required during application and handling of coal tar creosote are polyvinyl chloride (PVC), neoprene and NBR (Buna-N), viton and butyl rubber.

Formulators are responsible for registering their end use products under the Pest Control Products Act, and must have label precautions appropriate for the intended end uses; e.g., industrial applicators operating non-mechanized equipment must wear long-sleeved shirts, long pants, impermeable apron, gloves, boots and head covering impervious to the wood treatment formulation and a respirator and goggles.

FIRST AID TREATMENT:

If swallowed, call a doctor. If on skin, wash immediately with soap and water. If in eyes, flush with clear water. If irritation persists, obtain medical attention.

EYE CONTACT:

- Immediately flush eyes with flowing water, occasionally lifting the upper and lower lids.
- Flush eyes for at least 15 minutes.
- Wash contaminated skin with soap or mild detergent and water.
- If irritation develops, get prompt medical attention.

SKIN CONTACT:

- Immediately remove soaked clothing or articles in contact

- with the skin.
- Remove from skin with degrease hand cleaner.
 - Wash contaminated skin with soap or mild detergent and water.
 - If irritation develops, get prompt medical attention.

INHALATION:

- Immediately move the exposed person to fresh air.
- Apply artificial respiration if breathing has stopped.
- Keep the affected person warm and quiet.
- Get immediate medical attention.

DISPOSAL:

- Follow Provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
- Dispose of the container in accordance with Provincial requirements.
- For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of the Environmental Protection Service, Environment Canada.
- For small spills: recover free liquid and soak up residue with solid absorbent. DO NOT FLUSH INTO SURFACE STREAMS. INFORM ENVIRONMENT CANADA. This product is toxic to fish. Do not contaminate water by cleaning of equipment or disposal of wastes.
