DIRECTIONS

Before adding SPARKLE the pH should be tested and adjusted to within 7.2 to 7.6. Add muriatic acid if pH is high. Add soda ash if pH is low. SPARKLE should be added daily to maintain 0.6 to 1.0 parts per million available chlorine. The use of a test kit is recommended, as the air temperature and the number of

people in the pool will affect the amount of SPARKLE required. Under average conditions SPARKLE should be added daily to pool water according to the following chlorination guide.

Pool Capacity (Litres)	Daily Charge (Litres)
10,000	125-250 mL
20,000	250-500 mL
50,000	625 mL-1.25 L
100,000	1.25 L-2.50 L
250,000	3.25 L-6.25 L

Note: First application should be double the indicated amount.

SUPER CHLORINATION:

Every two weeks, add one week's charge of SPARKLE one application (1.5 L/10,000 L) to ensure proper control of algae, slime and fungus in hot weather. Avoid using pool until chlorine residual drops below 2.0 p.p.m. (approximately).

FOR SANITARY SWIMMING & WADING POOL WATER:

Add the correct amount of SPARKLE to the water daily. For wading pools add 5 mL SPARKLE for every 100 L of water daily. SPARKLE is recommended for use in all types of pools: vinyl lined, concrete and fibre glass.

CAUTION: KEEP OUT OF THE REACH OF CHILDREN NEVER MIX WITH OTHER POOL OR HOUSEHOLD CHEMICALS. Do not mix with a toilet bowl cleaner, rust removers. Avoid contact with skin and eyes. May be fatal or harmful if swallowed. Store only in original container tightly closed in a cool, dry place away from heat and sunlight, in an upright position.

FIRST AID TREATMENT:

Contains Sodium Hypochlorite. If splashed in eyes or on skin, flush thoroughly with water. If swallowed give one or two glasses of milk or warm water. Call Physician immediately. Keep patient warm.
