#### DIRECTIONS FOR USE:

Dairy Cattle (lactating and non-lactating) and Horses: For best results use a sprayer adjusted to deliver the recommended amount of spray so that it will deposit uniformly on the animal's hair as a fine mist. The spray droplets should not be so coarse that they wet the hide, not so fine that they float away. 30-60 mL is enough for an adult cow. Wash udder before milking. Repeat daily or as necessary.

Wipe-on Method for Horses: Apply with a cloth which is slightly moistened with the product. Use 30-60 mL for an adult horse. Repeat daily or as necessary.

Farm Building: (Dairy barns, milk rooms, beef barns, horse stables). Close doors and windows. Spray upward to fill the room with a fine mist. Use 200-300 mL of solution per 100 m<sup>3</sup>. Leave the room closed for 10 minutes before ventilating. All animals must be removed from barn/building before fogging. Ventilate treated areas thoroughly for at least 30 minutes before animal re-entry. Do not use in dwellings.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN: Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with skin, eyes and clothing. Wash thoroughly with soap and water after handling and before eating or smoking. Do not breathe spray mist.

Wash contaminated clothing before reuse. Do not contaminate feed, food or litter. Do not contaminate food handling equipment. Store in original container away from feed and food. Use only when milk room is NOT in operation. Cover or remove all milk and milking implements before spraying. After spraying wash all surfaces that may contact milk and rinse thoroughly with water before resuming operations. Do not contaminate any body of water. Highly toxic to crabs, fish and shrimp. Harmful to wildlife if allowed to contaminate lakes and streams. Do not apply fog within 8 hours to areas where livestock have received treatment. Do not use in areas where bee-keeping equipment or supplies are stored.

DISPOSAL PROCEDURES: Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of

the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the clean up of spills, contact the regional office of Conservation and Protection, Environment Canada.

FIRST AID: If on skin, wash thoroughly with soap and water. If in eyes, flush with clear water for 15 minutes; get medical attention. If swallowed, do not induce vomiting. Call physician immediately. Product contains Petroleum Distillate.
