DIRECTIONS

FOR MAXIMUM FLY CONTROL IN THE BARN

Livestock Spray - To treat cows against attacks of biting flies, spray animals once daily with a fine mist using an atomizer type hand sprayer Apply at a rate of 30-60 mL per animal over 6 months of age, depending on size. For calves use 30 mL. Spray should be enough to wet ends of the hair only, do not wet the hair or skin. Take care not to spray in the animal's eyes. Treat dairy cattle before milking. Do not use more often than once a day.

Space Spray-Fogging Farm Buildings

Use to kill flies and other flying insects.

- 1. Remove all animals from barn or building before fogging.
- 2. Close building and shut off all ventilating systems.
- 3. Using a spraying devise or ULV equipment to dispense spray as a fine mist, apply at a rate of 100 to 200 mL per 100m3. (Spraying time for the average dairy barn (480 m3) is about 1 1/2 minutes.)
- 4. Direct mist upwards to all parts of the room, especially windows and other light sources. Also direct mist into areas where insects are present. Do not remain in treated areas.
- 5. Spray only when temperature is under 32EC.
- Whenever possible, keep doors and windows closed for 30 minutes after each treatment.
- 7. Ventilate treated areas for at least 30 minutes before animal re-entry.
- 8. Following ventilation, clean up dead insects. The ideal time to fog is in the evening when the fly population is highest. For a severe fly problem also use a residual spray Fly Bait combined with a good sanitation program around your premises.

Contact Spray - To kill carpet beetles, silverfish, ants,

spiders, wasps, and hornets. Use an atomizer-type hand sprayer.

- Apply spray into all cracks and crevices and hiding places such as baseboards, moist areas, opening around sinks, drains and pipes, behind cabinets and storage areas.
- 2. Spray ant trails around door sills, window frames, or in ant nests. Insects must be contacted to be killed. Leave room closed for 20 to 30 minutes. Do not remain in treated areas. Repeat as needed.

PRECAUTIONS:

Flammable Mixture - Product contains Petroleum Distillate. Do not store, pour or use near fire or flame. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, water or foodstuffs. Do not use in milk processing plants or milking parlors.
