DIRECTIONS: Wet animal thoroughly. Apply shampoo working lather
thoroughly down to skin from head to tail. Pay special attention
to neck and hindquarters. Do not treat eyes, face or genitals of
pet. Allow lather to remain for 5-10 minutes. Rinse well and
dry. Repeat treatments as necessary.

For effective flea and tick control, treatment of the pet must be
combined with the cleanup and sanitation of any area used by the
pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag
after use) and wash the pet's bedding, living quarters, and
surrounding areas.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not contaminate food or feed. Keep away from animal's eyes and mouth. Wash hands after use. Consult a veterinarian before using on pregnant animals, sick animals, or animals under drug or other pesticide treatment. Do not on nursing animals or animals under eight weeks of age.
