PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. May be fatal if swallowed. May be harmful if dust arising from treated seed is inhaled. Wear a dust mask or respirator fitted to exclude dust. Avoid contact with skin, eyes and clothing.

Wash hands and face thoroughly after handling or using and before eating or smoking.

Wash contaminated clothing before re-use.

Do not consume alcoholic beverages immediately before or within 24 hours of working with thiram.

Do not use treated seed for feed or oil purposes.

A colourant MUST be added to this product to colour the seed, in accordance with the Pest Control Products Act and the Seeds Act and Regulations.

FIRST AID

If swallowed, drink one or two large glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit fluid is clear. Call a physician or poison control centre immediately. Never give anything by mouth to an unconscious or convulsing person.

For eyes, flush for at least 15 minutes with plenty of water and call a physician immediately.

In case of skin contact, wash thoroughly with soap and water.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

PREMIERE No-Dye Flowable is a very mild skin irritant, a mild eye irritant and a potential skin sensitizer. Treat symptomatically. Lindane is an organochlorine insecticide. Barbiturates may be given to control convulsions. Oxygen may be indicated. Keep patient quiet. Avoid use of morphine and adrenaline. Symptoms of Lindane Poisoning - Nausea, vomiting,

hyper-irritability, convulsions and/or coma, and other symptoms typical of organochlorine insecticide poisoning. Thiram may cause allergic eczema in sensitive skin. Consumption of alcoholic beverages increases the toxic effects of thiram.

STORAGE

Store product in a cool, dry, well ventilated area away from food and feed, and out of reach of children and animals. Keep product from freezing.

SPILL CLEANUP

If container is leaking, secure leak and contain any spill. Contact Zeneca Agro for cleanup and disposal instructions (see EMERGENCY TELEPHONE NUMBER).

For spills or leaks, contain the liquid and absorb on inert material (sand, clay, kitty litter etc.) and shovel into a sealable, waste container. After initial cleanup of surface, cover surface (other than dirt) with detergent and mix with a small amount of water. Scrub area with a stiff brush, let stand for 10 minutes and then absorb onto an inert material. Shovel into waste container. If spilled on earth, remove top 15 cm of soil and replace with clean soil. Dispose of all wastes including scrub brush in accordance with provincial requirements. See DISPOSAL section.

DISPOSAL

Recyclable Container:

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

- 1) Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
- 2) Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

Refillable Container:

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer) with the same product. Do not reuse this container for any other purpose.

Returnable Container:

Do not reuse this container for any purpose. For disposal, this empty container may be returned to the point of purchase (distributor/dealer).

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

10 L of PREMIERE No Dye Flowable treats 355 kg of seed

100 L of PREMIERE No Dye Flowable treats 3,550 kg of seed

1000 L of PREMIERE No Dye Flowable treats 35,500 kg of seed.

SHAKE OR STIR WELL BEFORE USING

PREMIERE No-Dye Flowable is a specially formulated product for control of seedborne black leg of mustard (*Leptosphaeria maculans* and *Phoma lingam*), seedborne alternaria black spot (*A. raphani* and *A. brassicae*), pre-emergence damping-off and seed decay diseases, and flea beetles in mustard. It is for use in liquid seed treating equipment.

NOTE: This treatment provides protection against flea beetles

only during germination and early emergence. For additional protection against flea beetles, apply a registered granular insecticide at planting and/or use a registered foliar insecticide.

This treatment provides only early season control against seedborne black leg and alternaria black spot.

APPLICATION: Apply PREMIERE No-Dye Flowable at 700 mL per 25 kg of seed. It is for use in liquid seed treating equipment. Best coverage is obtained when both PREMIERE and the seed to be treated, are stored above 0°C before and during treating of seed. A colourant MUST be added to this product to colour the seed, in accordance with the Pest Control Products Act and the Seeds Act and regulations.

STORAGE of treated seed: Treated seed may be stored for up to 4 months. Label all unplanted treated seed as follows:
"Poisonous to man and animals. This seed has been treated with thiabendazole, thiram and lindane for the control of diseases and insects. Do not use as food and feed. Do not sell to oil mills".

Treated mustard seed stored for periods in excess of 4 months may decrease in germination at a faster rate than untreated seed. Treated seed stored for more than 4 months should be tested for germination before planting.

WARNING: Do not use on seeds other than those listed on the label. PREMIERE No-Dye Flowable is unsuitable for other crops.

CAUTION: Wear a respirator fitted for dust protection and goggles to avoid dust that may be present during bagging or bulk handling of treated seed. Wear chemical resistant gloves, long sleeved clothing, goggles or safety glasses.
